## RULES

- Any coach with more than one team in the tournament MUST have an alternate coach for either team due to possible scheduling conflicts. Games will not be scheduled around coach's conflicts.
- Participants may play on ONE team only during the tournament. No exceptions!
- Age group is determined by the OLDEST member on a team. Players may play up in age group, but not down. No exceptions!
- All age groups will use the High School Federation Rules as a basis.
- 6 fouls will be allowed for all 4th grade teams.
- Each team is responsible for providing one scorekeeper/timekeeper for each game. A parent is fine for this.

## GAME LENGTH

- All games will use a running clock with the following exceptions: The clock will stop for all free throws, timeouts, injuries and any other time deemed necessary by the official. In addition, the clock will stop for all normal violations the last 2 minutes of each half.
- Grades 4,5 & 6 will play 8 minute quarters. Overtime is 2 minutes. Clock will stop for normal violations.
- Grades 7 & 8 will play 9 minute quarters. Overtime is 2 minutes. Clock will stop for normal violations

## TIME-OUTS

- Teams are allowed 2 full timeouts per game. Timeouts will not carry over to overtime. One timeout allowed in overtime.

## BALL SIZE

- All 4th, 5th & 6th Grade divisions (boys & girls) will use a 28.5" ball. 7th & 8th Grade boys divisions will use the full size ball. All teams must furnish their own balls for warm-up and games.

## TIME-OUTS

- Each team is allowed 3 time-outs per game. One time out allowed for each team in each overtime.
